ORDINANCE NO. 2018.7.1

AN ORDINANCE AMENDING CODE OF ORDINANCES, CITY OF FLATONIA, TEXAS, BY AMENDING CHAPTER 12, TRAFFIC AND VEHICLES, ARTICLE 12.03, OPERATION OF VEHICLES, DIVISION 3, YIELD INTERSECTIONS, SECTION 12.03.091, DESIGNATED, BY ADDING A NEW YIELD INTERSECTION DESIGNATION ON E. 4th STREET AT SCHOOL STREET WITHIN THE CHART OF DESIGNATED YIELD INTERSECTIONS CONTAINED IN DIVISION 3, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Flatonia, Texas has had its attention directed to the need to add a Yield designation on E. 4th Street at School Street to provide for the more orderly flow of vehicle traffic and for the safety of the motoring public and its citizens.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Flatonia, Texas:

- Section 1. That Chapter 12, "Traffic and Vehicles," Article 12.03, "Operation of Vehicles," Division 3, "Yield Intersections," Section 12.03.091, "Designated" be and it is hereby amended so that henceforth a Yield Designation on E. 4th Street at School Street is added to the chart of Yield Intersections.
- Article 12.03, Operation of Vehicles, <u>Code of Ordinances</u>, <u>City of Flatonia</u>, <u>Texas</u>, shall, except as amended herein, remain in full force and effect.
- Section 3. Any articles, sections or subsections of the <u>Code of Ordinances</u>, <u>City of Flatonia</u>, <u>Texas</u>, inconsistent with the provisions hereof are hereby expressly repealed.
- Section 4. If any provision, section, subsection, sentence, clause or phrase of this Ordinance, or the application of same to any person or set of circumstances is for any reason held to be unconstitutional, void, or invalid, the validity of the remaining portions or sets of circumstances shall not be affected hereby, it being the intent of the City Council in adopting this Ordinance that no portion thereof or provisions or regulation contained herein shall become inoperative or fail by reason of an unconstitutionality and all provisions of this Ordinance are declared to be reasonable.
- **Section 5.** This ordinance shall be effective upon the publication of the caption hereof in accordance with law.
