

Ordinance # 2017.10.1

AN ORDINANCE AMENDING SECTION 7.013 OF THE FLATONIA FEE SCHEDULE, APPENDIX A, FLATONIA CITY CODE, ESTABLISHING SOLID WASTE DISPOSAL RATES FOR THE CITY OF FLATONIA, AS AMENDED; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Flatonia has heretofore, by ordinance, set rates for the provision of solid waste disposal services by the City of Flatonia; and

WHEREAS, the City of Flatonia and Texas Disposal Systems have previously entered into a contract for the collection of solid waste in the City of Flatonia, Texas; and

WHEREAS, said contract provides for increases in solid waste disposal rates over the life of the contract; and

WHEREAS, it has been brought the attention of the City Council that new solid waste disposal rates need to be approved by the City Council so that the rates are sufficient to cover the cost to the City of Flatonia for such increases.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FLATONIA, TEXAS:

Section 1. That section 7.13, Solid waste disposal service rates, of the Flatonia Fee Schedule, Appendix A, City of Flatonia Code of Ordinance be, and it is hereby amended to read as follows:

(a) Residential.

(b) Commercial.

(1) Hand Pick-up:

<u>Number of Pick-ups per week</u>	<u>Inside City Limits</u>	<u>Outside City Limits</u>
1 (includes 1 cart)	\$43.21	\$58.28
each additional cart	\$17.84	\$24.06

(2) Rear load Containers (Dumpsters):

(A) 2 cubic yard dumpsters

<u>Number of Pick-ups per week</u>	<u>Inside City Limits</u>	<u>Outside City Limits</u>
1	\$109.26	\$145.83
2	\$215.02	\$257.71
3	\$323.84	\$387.87

* Extra pickups will be charged at a rate of \$64.84 per pickup.

(B) 4 cubic yard dumpsters

<u>Number of Pick-ups per week</u>	<u>Inside City Limits</u>	<u>Outside City Limits</u>
1	\$154.87	\$206.35
2	\$283.31	\$339.29
3	\$410.42	\$491.78

* Extra pickups will be charged at a rate of \$69.47 per pickup.

(C) 6 cubic yard dumpsters

* Extra pickups will be charged at a rate of \$74.10 per pickup.

(D) 8 cubic yard dumpsters

* Extra pickups will be charged at a rate of \$95.56 per pickup.

(3) Other Services.

(A) Casters and/or Lockbar - \$25.00 per dumpster.

(B) Recycling (pickup every other week):

4 cu. yd.	\$81.25	\$108.07
6 cu. yd.	\$91.25	\$121.31

Section 2. This ordinance shall be cumulative of all other ordinances of the City of Flatonia, and this ordinance shall not operate to repeal or affect any other ordinances of the City of Flatonia except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this ordinance, in which event such conflicting provisions, if any, are hereby repealed.

Section 3. The sections, paragraphs, sentences, clauses, and phrases of this ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional, such unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such unconstitutional or invalid phrase, clause, sentence, paragraph or section.

Section 4. The City Council officially finds, determines, recites and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this Ordinance and the subject matter thereof has been discussed, considered, and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.

Section 5. This Ordinance shall be effective immediately from and after its final passage and any publication in accordance with the requirements of the City of Flatonia and the laws of the State of Texas and shall apply to the December 2017, bill which covers the period between October and November 2017 billing cycle.
