AN **ORDINANCE AMENDING** THE CODE OF ORDINANCES OF THE CITY OF FLATONIA, TEXAS, CHAPTER 12 TRAFFIC AND VEHICLES, ARTICLE 12.03 **OPERATION OF** VEHICLES, DIVISION 3. INTERSECTIONS. AND **DIVISION** 4. **STOP** INTERSECTIONS. REPEALING ARTICLE \mathbf{BY} 12.03 **VEHICLES, DIVISION 3. OPERATION OF YIELD** INTERSECTIONS. AND **DIVISION** 4. INTERSECTIONS AND REPLACING BOTH DIVISION 3 AND DIVISION 4 IN THEIR ENTIRETY WITH A NEW ARTICLE 12.03, OPERATION OF VEHICLES, DIVISION 3. YIELD INTERSECTIONS, AND DIVISION 4. INTERSECTIONS, THEREBY CLARIFYING STREET NAMES, UPDATING CURRENT STREET SIGNAGE AND ADDING STREET SIGNAGE.

WHEREAS, the City Manager has determined that there exists a need to clarify and update the Code of Ordinances of the City of Flatonia, Article 12.03, Division 3., Yield Intersections, and Division 4., Stop Intersections to add correct street naming and update the tables in the Code of Ordinances reflecting current vehicular street signage; and,

WHEREAS, the City Manager has determined the most efficient means to update the Code of Ordinances is to repeal the current Article 12.03 Operation of Vehicles, Division 3. Yield Intersections, and Division 4. Stop Intersections, and replace with a new Article 12.03 Operation of Vehicles, Division 3. Yield Intersections, and Division 4. Stop Intersections, which amends, standardizes and organizes all street names and locations of yield and stop signs in the City of Flatonia;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FLATONIA, TEXAS:

Section 1. That Article 12.03 Operation of Vehicles, Division 3. Yield Intersections, and Division 4. Stop Intersections, be, and it is hereby repealed and replaced, to read hereafter as follows:

Section 2. This ordinance shall be cumulative of all other ordinances of the City of Flatonia, and this ordinance shall not operate to repeal or affect any other ordinances of the City of Flatonia except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this ordinance, in which event such conflicting provisions, if any, are hereby repealed.

Section 3. The sections, paragraphs, sentences, clauses, and phrases of this ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional, such unconstitutionality or invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such unconstitutional or invalid phrase, clause, sentence, paragraph or section.

Section 4. The City Council officially finds, determines, recites and declares that a sufficient written notice of the date, hour, place and subject of this meeting of the City Council was posted at a place convenient to the public at the City Hall of the City for the time required by law preceding this meeting, as required by the Open Meetings Law, Chapter 551, Texas Government Code; and that this meeting has been open to the public as required by law at all times during which this Ordinance and the subject matter thereof has been discussed, considered, and formally acted upon. The City Council further ratifies, approves and confirms such written notice and the contents and posting thereof.

Section 5. This Ordinance shall be effective immediately from and after its passage and any publication in accordance with the requirements of the laws of the State of Texas.
