## **ORDINANCE #2017.9.1**

AN ORDINANCE MAKING APPROPRIATIONS FOR THE SUPPORT OF THE CITY OF FLATONIA, TEXAS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2017; APPROPRIATING MONEY TO A SINKING FUND TO PAY INTEREST AND PRINCIPAL DUE ON THE CITY'S INDEBTEDNESS; AND ADOPTING THE ANNUAL BUDGET FOR THE CITY OR FLATONIA, TEXAS FOR THE 2017-2017 FISCAL YEAR WHICH INCLUDES THE GENERAL FUND AND THE UTILITY FUND.

WHEREAS, the annual budget for the City of Flatonia, Texas (appended as Exhibit "A") for the fiscal year beginning October 1, 2017 and ending September 30, 2017, was duly presented to the city Council by the City Manager; and

**WHEREAS,** a public hearing on said budget was ordered by the City Council and was held on September 5, 2017 and notice of said public hearing was caused to be given by the City Council; and

**WHEREAS,** said notice was published in the <u>Flatonia Argus</u> and said public hearing was held according to said notice.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FLATONIA, TEXAS:

- SECTION 1. That the City Manager's proposed Fiscal Year 2017-2017 Budget for the fiscal year beginning October 1, 2017 and ending September 30, 2017, as shown in words and figures in Exhibit "A", is hereby approved in all respects and adopted as the budget of the City of Flatonia, Texas for the fiscal year beginning October 1, 2017 and ending September 30, 2017, in compliance with provisions of Chapter 1, Section 5 of the Flatonia City Code which sets forth certain very specific requirements as to the City of Flatonia,
- **SECTION 2.** That there is hereby appropriated the sum of \$ 1,829, 464 to the General Fund for the payment of operating expense and necessary capital outlay for the City Government.
- **SECTION 3.** That there is hereby appropriated the sum of \$\(\frac{3}{413,027}\) to the Utility Fund for the operating expense and necessary capital outlay for the Utility Departments.



- **SECTION 4.** That the City Council hereby confers upon the City Manager general authority to contract for expenditures without further approval of the Council for all budgeted items the cost of which do not exceed the constitutional and statutory requirements for competitive bidding.
- **SECTION 5.** That this ordinance shall become effective from and after its passage.

**PASSED AND APPROVED** on this 12<sup>th</sup> day of September, 2017, with 5 Council members voting for and 0 Council members voting against.
