- 1. TDA Tx CDBG Contract 7219150 sewer and water project. (funding \$35,245 to cover grant amount and low bid+\$15,000 City match)
- 2. COVID-19 Small Business Utility Grant Program (funding \$13,500)
- 3. Restrooms at 7-Acre Park (funding \$8,000)
- 4. Sidewalk extensions at the railroad crossings on the west side of Market St. and east and west sides of Penn St. West side of Penn Street to get the priority.
